# 1. MANIFESTO

## It's RED ALERT (CODE ROOD) for the climate!

Oil, gas and coal must be kept in the ground in order to stop climate change. But the Netherlands is lagging behind in tackling the climate problem. The ports of Rotterdam and Amsterdam are among the biggest in the world when it comes to oil, petrol and coal. Meanwhile, the climate is changing at a faster pace than the measures taken by politicians and corporations. That's why, on the 24th of June, we will raise the alarm with hundreds of concerned people: it's RED ALERT (CODE ROOD) for the climate!

Climate change is a threat to all life on our planet. Human action has already caused the temperature on Earth to rise by one degree Celsius, and the consequences are affecting us more and more severely. The lives of many people, especially those in the Global South, have already been destroyed and an increasing number of animal and plant species are threatened with extinction. In many countries, social, economic and political circumstances are worsening and tensions among countries are rising, too. Oil, gas and coal must be kept in the ground in order to stop climate change.

When it comes to taking a serious approach to tackle the climate problem, the Netherlands is falling far behind in all respects. Coal plants are still open, the NAM (Dutch Petrol Association) is still pumping billions of cubic metres of gas from the province of Groningen, traffic flows on the roads and in the air continue to increase and industrial agriculture and factory farming reign supreme. As a result, greenhouse gas emissions keep on rising. On the 24th of June 2015 the judge issued a historic verdict in the so-called Urgenda ruling: the Dutch state was ordered to protect its citizens from dangerous climate change. Effective measures are necessary to strongly reduce CO<sub>2</sub> emissions. Instead of setting to work immediately and taking its duty of care towards its population seriously, the Dutch government decided to appeal against the ruling – even though the Netherlands is already lagging behind internationally. Dutch politicians constantly evade their responsibility by pointing to other countries or by putting off policies. Meanwhile, emissions keep on rising and the fossil fuel industry has a free hand, while the consequences of climate change are affecting us already.

Two years after the historic Urgenda ruling, we are taking action. Because we have no time to lose, we will draw a red line against the fossil fuel industry on the 24th of June, in the port of Amsterdam. As the the biggest petrol port in the world and the second-largest coal port in Europe, the port of Amsterdam is a symbol for the system that we resist. Through actions of civil disobedience, we will severely disturb regular operations. In so doing, we will force the Netherlands to close its gates to the biggest polluters, who currently face no obstacles, particularly in the ports of Rotterdam and Amsterdam, and the Groningen gas fields.

We will keep on carrying out actions until we have achieved the following:

- The Netherlands leads the way in the transition to a sustainable society, in order to contain climate change to 1.5 °C.
- The ports of Amsterdam and Rotterdam have closed their gates to the climate-wrecking fossil fuel industry.
- All gas- and coal- fired power stations have been closed.
- There is no more gas extraction in Groningen. Earthquake-related damage has been generously compensated.
- A just transition fund is in place for all workers in the fossil fuel industry and all other sectors that are affected by the transition.
- There is a fair and sustainable economy that respects the planet and all who live on it. In order to achieve this, international trade policy has been radically reformed.
- The Global North acknowledges its historical ecological debt and repays it.
- The Global South, after all, bears the least responsibility for climate change, but is affected by its destructive consequences first and most strongly.
- The borders have been opened. In this way, we relieve the negative consequences of climate change for the people who are already being impacted by it.
- The Global North supports the transition to a sustainable society in the Global South with the financial means and knowledge deemed desirable and necessary by the citizens of the Global South.

People, the living environment and the climate are being sacrificed for the profits of the destructive fossil industry. This shifts the burden to the workers, who risk losing their job as the fossil industry nears its end. That's why, as part of our struggle, we show solidarity with the workers. For these people, a good solution must be found; we are in favour of a sustainable society, with a fair economy which respects the planet and those who live on it. Not only should fossil fuels stay in the ground, it is also necessary that rewarding job opportunities are provided for everyone, now and in the future.

When we join forces, the power of the fossil fuel industry can be broken, and a fossil free society can be reached. Together we are building a resilient movement that dares go one step further. Because the climate problem is so urgent and threatening – and politicians and corporations are doing so little to solve it – we deem it necessary and justified to switch from large-scale public protest to large-scale civil disobedience. We won't allow possible attempts to abuse our resistance against this industry for reactionary or nationalist ends, and we will condemn them strongly. Civil disobedience is the deliberate breach of laws and rules to enforce social change. We are convinced that the use of this form of action is a necessary and legitimate step to curb climate change. With our action, we aim to raise the alarm for all of society: rise up! Only through massive resistance will we succeed in ending the age of fossil fuels. Necessity knows no law!

We are part of a worldwide movement against climate destruction at the hands of the fossil industry. People all over the world are standing up for the climate. We are stopping lignite mines in Germany, coal plants in India, pipelines in the US, gas extraction in Groningen, fracking in Brazil and oil drilling in Nigeria. And on the 24th of June, we will draw a line in the Port of Amsterdam. Together, we are stopping climate change! It's RED ALERT (CODE ROOD) for the climate!

## 2. ACTION CONSENSUS

On the 24th of June in the harbour of Amsterdam we will participate in acts of civil disobedience together in order to strongly disrupt the fossil fuel industry. Due to the urgency of the climate problem we see this as necessary and justified – to go from public protest to civil disobedience.

We need to stop oil, coal and gas as soon as possible in order to halt further climate change. More and more people are starting to realize this. People are stopping coal power stations in India, pipe lines in the US, lignite coal mines in Germany, fracking in Brazil and oil drilling in Nigeria. Together we form a global movement against the climate destruction wreaked by the fossil industry.

Exactly two year after the historic court case of Urgenda (and 900 others) we will go into action. In Amsterdam, which is the largest petrol harbour in the world and the second largest coal harbour in Europe, we will together draw a line against further transport and burning of fossil fuels – one of the major causes of climate change and its dramatic consequences. We will stand in solidarity with all people globally who are hit by the social and ecological destructions of the fossil fuel industry. This action will offer different participation levels. Everyone who wants to participate will be able to. Experience with similar forms of protest is not required. Using a variety of banners, symbolic objects and posters, we will focus attention on the many destructive effects of the fossil fuel industry.

We will together be responsible for the success of the action. During the action we will create a situation that is transparent for all participants. We will support each other's well being. We will block and occupy with our bodies and we will not damage machinery or infrastructure. The safety of the participants and the harbour employees is our highest priority. We are thoroughly prepared for a safe entrance to the action location and a safe execution of our blockade. Everyone will be well informed on the safety rules in the harbour which deal with handling fossil fuels.

We will act calmly and in a controlled manner. We will act in a de-escalating manner and we will not be provoked. Our action is not aimed at the harbour employees or the police. Our actions are aimed at the policy of the fossil fuel industry, the harbour company and the government. We understand that employees are dependent on their jobs to provide for themselves and their families. This is why we support the union's demand for a coal fund. For us, climate justice does not only mean keeping fossil fuels in the ground. It also means that the necessary transition will provide fair employment opportunities for everyone, in an economy that supports the earth and all its inhabitants, now and in the future.

## **WE ARE THE CAMP TOGETHER**

This is a collective camp. This means that we bear common responsibility to make the camp run smoothly, that it stays clean and to make sure that everyone feels welcome, comfortable and safe. There will be calls during the general assemblies to fill in specific roles. This can be anything from helping to prepare the food, to doing the dishes, to make sure there are people at the info tent or clean the toilets.

If you see people misbehave, then call them on their behaviour. Do not only clean up your own trash but also trash that other people might have forgotten to take with them.

What follows are a couple of rules and guidelines to make sure everyone experiences the camp in a nice manner. Read them carefully. Some rules or guidelines might be new for you. Try to keep an open mind for new perspectives. Discuss these things in a friendly manner and try to empathize with your fellow beings.

## **GENERAL BEHAVIOUR**

It is our ambition to have the camp as 'safe' shared space where any form of discrimination or repression is not tolerated. Racism, sexism, ableism (discrimination and marginalising of people with diverse bodily and intellectual abilities), classism, homophobia, transphobia and islamophobia are not allowed. Sexual violence and abuse will not be tolerated. Maintain an open mind for the fact that you can be called out in the case that your behaviour conflicts with the house rules. IN those moments try to be understanding rather than to get defensive. If you experience one or several things of the above, you can notify one of our buddy team members/ confidence persons. You can find the contact information for these people in the info tent.

## **JOURNALISTS ON THE CAMP**

The media and communications (MECOM) working group has written a protocol for journalists. In this manner we want to make sure that everyone feels that their privacy is safeguarded at the camp while also offering media and documentary makers the opportunity to give report on the action.

Journalists should report their presence to MECOM either by mailing coderood-mecom@riseup.net or on arrival at the camp. The journalists can sometimes be accompanied by MECOM on the camp. All media, journalists, photographers and documentary makers will get a batch from MECOM, which they can show to participants of Code Rood to proof that their presence has been registered by MECOM. If they want to interview the participants they should always directly tell that they are journalists. Participants are always free to decline and show them one of the press spokes people. The names of participants can only be cited with explicit permission of the participant.

Journalists are free to walk around in the common areas and film during the two hours after lunch. Only a few documentary makers and journalists are invited to report outside these hours. Participants can always check this at the press tent. On any other time slot anyone should first ask if they can take pictures or film of people. They should always have explicit permission to do so before filming or taking pictures.

It is never allowed to take pictures or film during the general assemblies. It is also forbidden to do so in the meditation tent and at places where people sleep, since they should always feel safe to retreat there.

Anyone is of course allowed to talk with the media (on Friday there is a media training). The media & communications working group will also organise specific 'media-friendly' affinity groups with people who enjoy talking to media and are prepared to do so. Please contact MECOM if you would like to join a group like this.

### **(POLITICAL) PARTIES AT THE CAMP AND DURING THE ACTION**

The camp and the action are of course great places to show with which party, organisation or group you identify. Not only is it interesting to see the different backgrounds, it's also a good moment for discussions and conversations. We provide space for promotion, for example, at the information tent where you can leave flyers and stickers.

However, we do ask groups, organisations and parties to be modest with their 'branding'. A flag or shirt is of course OK. Twenty big flags and huge banners not. This can be overwhelming and have a big influence on the atmosphere and image of the camp and action. Code Rood is organised bottom-up and horizontally by individuals who voluntarily put a lot of time into this project. Therefore, it's not intended to make statements as a group, and not claim the hard work of others.

Especially political parties who are active in Parliament are asked to show constraint. People who are part of a political party are always welcome to join as a person (instead of representing their party). The best way for political parties to show their support is to sign our manifesto or to publish a solidarity statement on their website or social media channels.



## **ANIMALS ON THE CAMP**

A climate camp is not a good place for our four legged friends. Please leave them home if possible. This is difficult, but experiences from other camps prove that this is necessary. A guide dog is of course permitted.

If you really can't find another option or you are dependant on your pet as support, you can bring your animal. However, they should always be on a leash! Be aware that people might be scared of dogs, even yours, no matter how friendly it is. Make sure your dog to clean your dogs disposals at the camp and don't get offended when someone has problems with your animal's behaviour. Please keep your animal away from the mediation tent, the first aid tent and the kitchen!

Do not bring any animals during the action!

## **TOPLESS**

When it's really warm, many people take off their shirts. However, in our societal context taking off your shirt is a privileged that not everybody has and symbolic for specific oppressive structures in our society. Being confronted with a naked torso can provoke negative associations and lead to discomfort in some people. Since not everybody is aware of the complexities related to this issue we suggest the following guidelines at the camp.

In our society the sight of a naked male torsos (that matches the Western beauty standard) is socially accepted, whereas the bodies of women\*, trans\* inter are often objectified and sexualized. People affected by sexism but choose to walk around top-less in response often get stared at, judged and even confronted with aggression. This sexualization of bodies is at the root of many social taboos: While men are relatively free to show their bodies, female\*, trans\* inter bodies are subject to strict censorship (eg by having to cover their nipples).

We live in a world where sexual violence and abuse is not an exception but a social reality. In the case when people have experienced sexual abuse the unwanted confrontation with a naked male torso can bring up undesired memories and provoke emotional stress.

Of course, showing your naked torso can also be an act of liberation and emancipation against oppressive societal structures and a strategy to counteract current social norms. However, this is a difficult and often tiring process that not everybody feels able to, or wants to engage in. Therefore it is important that people are able choose themselves when they want to be confronted with naked bodies.

In our struggle for a better world it needs to be acknowledged that we are starting in a society where hetero- normative norms and sexual abuse exists. Therefore we hope to create a space in this camp where everybody is aware/ becomes aware of their own privileges and to experiment with alternatives. Nevertheless, we must recognize our limits, and in particular the boundaries of others, especially since we are living together for a limited time in relatively limited space. This

means that the climate camp is not a living utopia for all, but a way to get there.

That's why we ask everybody to reflect and to do a quick self-check before taking off their shirt. If you want to take off your shirt, ask the people around you if they feel comfortable with it. During the plenary sessions, workshops, eating hours and in the First aid-, meditation- and info tent everybody is asked to keep their upper body covered.

## **ALCOHOL AND DRUGS**

We understand it can be nice to have a drink from time to time. However, we aim to keep the camp alcohol free for most of the time. Therefore, we have assigned different zones where you can enjoy a drink (for example in the bar).

Never ever smoke inside the tents! Some people can be really bothered by the smoke. Also there is a danger of fire. Furthermore, all the cigarette butts should be picked up. Because of all these reasons we ask you to only smoke in the designated areas.

Never use hard drugs at the camp

During the action we will all be sober! Also for smoking there can be different rules. If we are, for example, in the surroundings of coal or gasoline, it's unsafe to smoke and we will not do that under any circumstance. During the action briefing on Friday evening there will be more clarity about the different safety risks and guidelines during the action.

## 4. SAFETY

We are a big group of people, so we have to take care of each other. Don't light any fire in the surroundings of dry grass and close to tents.

We make the camp together which also means we have to watch it together. If you see anything suspicious, please report this at the information tent or with the people who are doing security watch shifts. You can find the number at the information tent.

There are security watch shifts during the whole day and night. If you are able to take on a shift, please do so!

In case of emergency we will sound off an alarm. If you hear the alarm, you have to go to the main tent immediately! Also do this when it's during the night and you have to leave your own tent. The situation can be unsafe, so it's important to be ready together.

### **FIRST AID AND FIRE SAFETY**

There is a first aid tent on the camp where there will always be help available. During the action on Saturday a team of medics will be supporting the action, recognizable by their jackets. All tents are equipped with fire extinguishers. On behalf of fire safety we request you to keep the paths free and only smoke in the designated areas.

There is also a buddy team, which can be contacted at any time. More info on their contact details can be found by visiting the info tent.

## 5. LEGAL INFORMATION

### **ARRESTED? THIS IS WHAT YOU NEED TO KNOW.**

There is a chance that you will be arrested during this Code-Red action. The arrest group (AG) team is ready for you and can be reached on number: 06-44972490. If you see arrests during the action, please report this to them, remember that you should never mention names over the phone.

We have secured the services of **Willem Jebbink of Jebbink Soeteman Attorneys** in Amsterdam to provide assistance after arrest. His telephone number is **06-55791837**. Members of his legal firm are on standby; Willem and 3 of his colleagues, to be requested by you and assigned as your lawyers if you are arrested. If you have a lawyer with whom you prefer to work, that is no problem of course, please give their details to the AG team.

**Make sure to write the name of your lawyer and the number you receive from the AG team somewhere on your body with a marker.**

### **WHAT TO EXPECT;**

If you are arrested, the police can initially hold you for a minor offence for 6 hours, or for a crime 9 hours. They can frisk you and take away any personal possessions you are carrying. If you do not give your name, don't have your ID card with you, or choose not to give your identity, the police can hold you for another 6 hours to identify you in relation to the suspected violation. In these circumstances they will be able to hold you for up to  $6 + 6 = 12$  hours for a minor offence (such as trespassing). When suspected of a crime, the police can hold you for 9 hours + 3 days and 15 hours = 4 days. This counts from the moment you are **brought before the Assistent District Attorney / Prosecutor (Hulp-officier van Justitie)**, not from the moment you are arrested. *NB: The time between 12 midnight and 9 am is not included in the time calculation; this can in practice add up to 9 hours to the time you can be held, which means for suspicion of a minor offence; a maximum of 21 hours.*

*You are not required to:*

- Give your name -. it is legal to remain anonymous.
- To make a statement.
- Sign anything.
- Enter into any proposed transaction or agreement.

*They are allowed to:*

- Take photos and fingerprints if you are staying anonymous. They are likely to do this.
- Subject you to questioning (except at night)
- Put you in front of a mirror wall from behind which "witnesses" can be asked by police if they recognise you.
- Transfer you to another police station.

## STAYING ANONYMOUS?

You have the right to not give your name, whatever the police try to tell you. Keep in mind that if you decide to stay anonymous, you must check that you really don't have anything on you with your name, or anything your name can be extracted from (like your phone) !! Staying anonymous has benefits: you will avoid a criminal record on your name (officially called - 'a note in your legal extract') and this confuses their system. It also makes it easier for others participating in actions with you that do not have official papers not to stand out for targeting. It also has disadvantages; the police can hold you longer, supposedly in order to establish your identity. In such a case you will be issued an anonymous 'NN' number (NomenNescio). It's important to remember this number !!

*In custody* (3 days, 15 hours possible plus 3 days, 15 hours)

You get a paper stating that you are taken in custody ("in verzekering gesteld") and which crimes you are suspected of. You need to indicate who your lawyer is and that you want to see him / her, otherwise the police will assign you a lawyer. You can ask to make a phonecall, but this is not an automatic right. If they do let you make a call, please remember that it is not private.

### *Foreign detention*

Nowadays, activists who do not give their names are occasionally placed in foreign detention. This means that you are being treated as if you are staying illegally in the Netherlands as a result of not wanting to identify yourself. Once you have been told that you are being held in foreign detention and will be interrogated, you have the right to see a lawyer. In this situation, continue asking for your preferred lawyer! Lawyers for foreign detention are different to the lawyers for standard detention. **Martijn Strooij van Hamerslag & Van Haren lawyers** are on standby for this action. Also indicate that you want to speak to your preferred lawyer before the first interrogation, you are entitled to this and this is very important. You do not have the right to silence, as in criminal law. Under foreign detention law you have an obligation to cooperate. **It's therefore wise to speak with your lawyer first.**

## RELEASE

If/when your items are returned, the police will ask you to sign for them. You are not required to sign for them. You can sign with an X if you wish. Signing your name can give away your identity. When you are released, please make contact with the arrest group (AG). They want to know how many people were arrested and like to know when you're released so they can cross you off their list. Among other things, they can advise you on what to do if you receive a summons.

## ETHNIC PROFILING, RACISM, UNEQUAL TREATMENT

We want to mention that the points described above indicate what the legal procedures are and what your rights are within them. Police racism, ethnic profiling, transphobia, discrimination against people who do not conform to police norms, etc., mean the same rules are often applied differently and could result in more severe treatment. It is legally difficult to fight against such treatment, we can only call this out and call on each other before, during and after the action to stand in solidarity as much as possible.

As activists do not allow this solidarity to be broken by repressive police behaviour. If people wish, after the action they can be assisted by the Support & Recovery team (**sr-team [at] xs4all.nl**).

## GENERAL KEY POINTS:

1. If you are going to take part in an activity with a likelihood that you will be arrested, it is useful to tell this in advance to someone you trust. That person can then contact the arrest group (AG), who are able to inform them who your lawyer is, call (in sick?) to your school or place of work for you if you have stipulated it, and or care for your plants or pets etc. There is an AG form you should fill in in advance, on which you can give the details of your contact person.
2. You have the right not to give your name.
3. **DO NOT ACCIDENTALLY DECLARE IT, EITHER ABOUT YOURSELF OR ABOUT OTHERS !!** They are not talking to you for the sake of a good conversation between equals, but to discover information about you and others. The more you talk, the greater the chance of conviction and punishment. Ask why you are arrested, ask for your lawyer and do not say anything else. The police are trained to get information from you in an inobvious manner. Don't fall for it. It is the job of the police to convict you, so they want to collect as much as possible evidence against you. The police have no other task than that. If you wish to justify yourself in principle for the action, then the place for this is the courtroom where you have the right to a final word.
4. The police are obliged to inform you why you have been arrested.
5. **You have the right to see your own lawyer (Willem Jebbink), but you have to ask for him personally!** Always ask your lawyer for his / her card to check they are who they say they are.
6. You are entitled to vegetarian / vegan food if requested and medical assistance if needed. Claim these rights. The police will be difficult about supplying you with these things, especially if you stay anonymous. But exhibiting solidarity and support for each other by making these demands is important. Together you are strong!
7. Women may only be touched by female agents, men only by men.
8. **Transgender individuals are to be handled by an agent of the gender that is in their passport.**
9. You are entitled to an interpreter at the hearing if you do not speak Dutch well. The police must arrange this for you. Always request an interpreter for your own language.
10. The police will not adhere to the rules, and will try to make your stay unpleasant. They will apply rules differently to different people. Try to prepare yourself in advance for this mentally. The police will typically pull every trick in the book to get you talking. Prepare yourself as best you can beforehand. Do not be intimidated, keep calm and remember: help is on it's way!
